4. FIRST AID MEASURES

HEALTH EFFECTS

SWALLOWED: If a significant quantity is ingested SEEK IMMEDIATE MEDICAL ATTENTION. Give water or milk

to drink, DO NOT induce vomiting. If vomiting occurs get immediate medical attention due to

aspiration into lungs risk.

EYE: Immediately irrigate with copious amounts of water for at least 15 minutes. Eyelids to be held open. In

5. FIRE FIGHTING MEASURES

FIRE/EXPLOSION HAZARD

HAZARDS OF USE/STORAGE: Product is not a combustible liquid according to AS 1940.

HAZARDS FROM COMBUSTION PRODUCTS: There is no risk of an explosion from this product under normal

PERSONAL PRECAUTIONS: As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include rubber, PVC. 6. ACCIDENTAL RELEASE MEASURES (CONT)
