4. FIRST AID MEASURES

<u>HEALTH EFFECTS</u>	
SWALLOWED:	If a large quantity is ingested seek immediate medical attention. Give water to drink. DO NOT induce vomiting. If vomiting occurs get immediate medical attention due to aspiration into lungs risk.
EYE:	Immediately irrigate with copious amounts of water for at least 15 minutes. Eyelids to be held open. In all cases of eye contamination it is a sensible precaution to seek medical advice.
SKIN:	Remove contaminated clothing and wipe off excess material. Wash skin thoroughly with plenty of water. High pressure injection through the skin requires URGENT medical attention for possible incision, irrigation and/or debridement. If swelling/redness/blistering or irritation occurs, seek medical attention.
INHALED:	Remove victim from exposure to fresh air – avoid becoming a casualty. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist. If breathing laboured and patient cyanotic (blue), ensure airways are clear and have qualified person give oxygen through face mask. If breathing has stopped apply artificial respiration at once. In the event of cardiac arrest, apply external cardiac massage and seek urgent medical aid.
FIRST AID FACILITIES:	Normal washroom facilities are generally suitable. Ensure an eye wash station and safety shower is available and ready for use.
ADVICE TO DOCTOR:	Treat symptomatically.

5. FIRE FIGHTING MEASURES

FIRE/EXPLOSION HAZARD

HAZARDS OF USE/STORAGE:	Product is not combustible under normal conditions. Under fire conditions it will break down and the organic component may burn. It is not considered to be a significant fire risk.
HAZARDS FROM COMBUSTION PRODUCTS:	Heating may cause expansion leading to a violent rupture of the containers. Product decomposes on heating and may produce toxic fumes of carbon monoxide.
FIRE-FIGHTING RECOMMENDATIONS:	If safe to so, remove containers from path of fire. Keep storage tanks, pipelines, containers, fire exposed surfaces, etc. cool with water spray. Avoid spreading liquid and fire by water flooding.

6. ACCIDENTAL RELEASE MEASURES

SPILLS & DISPOSAL:	Slippery when spilt. Avoid accidents, clean up immediately.
	CLEAN-UP PROCEDURE - SMALL SPILLS (20L or less): Absorb or contain liquid with sand, earth or spill control material. Shovel up using non- sparking tools and place in a sound labelled sealable container for subsequent safe disposal. Place leaking containers in a sound labelled drum. Rinse then scrub contaminated surfaces with water. Retain washings as contaminated waste.
	CLEAN-UP PROCEDURES - LARGE SPILLS (Greater than 20L): Transfer to a sound labelled, sealable container for product recovery or safe disposal. Treat residues as for small spills.
	PERSONAL PRECAUTIONS: Extinguish naked flames. Remove ignition sources. No smoking. Avoid sparks. Avoid contact with skin, eyes and clothing. Evacuate the area of non-essential personnel. Shut off leaks, if possible without personal risk. Do not breathe vapours. Ventilate contaminated area thoroughly. Dispose of according to local regulations.
OTHER INFORMATION:	PROCEDURES IN CASES OF LEAKAGE OR BREAKAGE: Stop the source of the leak or release and contain spill if possible. Ventilate area. Use respirator and protective clothing outlined in this MSDS. Cover spill with inert absorbent earth or wipe up. Clean up and place in a sound labelled disposable container. Scrub contaminated area with water using a stiff brush. Pick up liquid with additional absorbent material and place in a sound labelled disposable container. Prevent contamination of groundwater or surface water.

7. HANDLING AND STORAGE

PRECAUTIONS FOR SAFE HANDLING:	When handling product in drums, safety footwear should be worn and proper handling equipment should be used. Prevent spillages. Ensure the appropriate personal protective equipment is used when handling this product. Ensure high level of personal hygiene is maintained when using this product. That is; always wash hands before eating, drinking smoking or using the toilet.
SAFE STORAGE CONDITIONS:	Keep containers closed at all times. Store in a cool place out of direct sunlight. Store away from oxidising agents and acids. Check containers regularly for leaks.
CORROSIVENESS:	Not corrosive.
STORAGE REGULATIONS:	Store in a well ventilated place away from ignition sources, oxidising agents, acids, foodstuffs and clothing. Keep containers closed when not in use.
